**Developments in Residential Solar - what you can expect to see in residential solar as the planet gets warmer, electricity prices go up, and the grid gets less reliable.**

**Mark Durrenberger**

Founder and President of New England Clean Energy. Founded in 2006, New England Clean Energy, based in Hudson, Massachusetts, has been installing solar electric systems for 16 years. They have installed more than 2,500 systems in Eastern Massachusetts, Rhode Island, Southern New Hampshire, and Southern Maine. They recently added solar-charged batteries to their product offerings.

Mark is active in the development of Massachusetts solar policy and contributes to the development of building code as it pertains to residential solar installations. Mark also regularly presents about solar and teaches CSL renewal classes for the Home Builders and Re-modelers Associations of Central and Western MA. Mark carries a current Construction Supervisors License, has a BS in Nuclear Engineering and an MS in Energy Engineering from the University of Massachusetts Lowell.

**In the session, I'll discuss why solar electric systems are so popular, and I'll discuss the coming technology for panels, mounting hardware, inverters, and batteries. I'll go over a typical plan-set and discuss some of the current and evolving building and fire codes and their impacts on solar installation. In addition, I'll spend some time on solar for new construction vs retrofits and I'll spend a bit of time on ground mounted installations.**
